Fee Schedule The initial membership fees are prorated so that applicants only pay for part of the year in which their applications are submitted. Memberships renew on January 1st at the beginning of the calendar year. Membership is renewed in January of Each Year, with the **annual membership fee of \$120 for both Senior* and Regular Members.** Include an **initial application processing fee of \$100** with Member Applications and **\$150** with Senior Professional Member Applications*.
